Employees are required to understand the cognitive ability, conduct reality orientation therapy to elderlies according to the instructions by healthcare professionals, monitor and document elderlies' performance properly, in order to help elderlies grasp information related to time, places and people.

	<ul> <li>Conduct reality orientation therapy using appropriate techniques and skills, according to the cognitive ability of elderlies, such as         <ul> <li>Explain to elderlies the theme of the session</li> <li>Use tools for reality orientation therapy appropriately</li> <li>Provide sufficient instructions and explanations</li> <li>Create an interactive environment to encourage the participation of elderlies</li> </ul> </li> <li>Provide appropriate assistance and intervention if required, such as         <ul> <li>Allow adequate time for elderlies and never rush them</li> <li>Prevent arguments between elderlies and take immediate actions should argument arises; provide clear instructions to resolve</li> </ul> </li> <li>Summarize the therapy after finishing the group session, for example         <ul> <li>Praise elderlies for their performance</li> <li>Thank them for their participation</li> <li>Tell them the schedule for the next session, etc.</li> </ul> </li> <li>Report elderlies' performance to healthcare professionals, including their ability to concentrate, their level of participation, and their mood.
