	<ul style="list-style-type: none"><li>◆ Supervise the implementation of security arrangements and procedures for ships, warehouses, cargo transport equipment and on site</li><li>◆ Supervise the implementation of staff registration and vehicle access control for ships, warehouses, cargo transport equipment and on site</li><li>◆ Ensure that the security staff use security equipment required correctly</li><li>◆ Verify the staff registration and qualification</li><li>◆ Ensure that there is sufficient and suitable security equipment provided on site</li><li>◆ Check, issue, circulate and file security documents</li><li>◆ Ensure that the security staff are provided with sufficient training in cargo transport security</li><li>◆ Pay attention to any irregularities in cargo transport, such as omission, incorrect number of cargoes, etc.</li><li>◆ Examine and record container sealing devices and their code number</li><li>◆ Send cargo transport information provided by shippers to relevant customs departments or organizations</li><li>◆ Check security operation records and reports</li><li>◆ Compile reports on security service contractor's performance</li></ul>
