With the launch of the "Vocational Qualifications Pathway" (VQP) in ten industries (including Automotive, Property Management, Banking, Elderly Care Service, Printing & Publishing, Insurance, ICT, Logistics, Retail, and Security Services), many enterprises, training institutions, and government departments have referred to the VQP as a standard for designing learning programmes or establishing their licensing criteria. Recognising that numerous organisations have accumulated considerable experience in applying the VQP, the Qualifications Framework Secretariat (QFS) held the "Sharing Session on the Applications of Vocational Qualification Pathway in Industry Development and Talent Training" on 7 November, 2023 to provide insights and share success stories with other organisations interested in adopting the VQP.

Experience Sharing by Stakeholders

Guest speakers who attended the sharing session included representatives from the Electrical & Mechanical Services Department (EMSD), the Social Welfare Department (SWD), Asia Airfreight Terminal (AAT), the Employees Retraining Board (ERB) and HKU School of Professional and Continuing Education (HKUSPACE). Ir. Gordon NG of EMSD and Ms. Pheon TSANG of SWD shared their

experiences in applying the VQP to the Voluntary Registration Scheme for Vehicle Mechanics (VRSVM) and course accreditation in the Elderly Care Service industry respectively. Ir. NG remarked, "VQP helps to enhance the service level and professional image of practitioners. The four registration classifications within the VRSVM have been linked with the Recognition of Prior Learning (RPL) mechanism under the Qualifications Framework (QF), allowing technicians to convert their valuable experience into recognised qualifications within the QF."



Ms. TSANG of SWD also shared, "The VQP can provide clear career progression paths and advancement opportunities for practitioners in the elderly care service industry. For example, care workers who have extensive work experience but lacking a local Form 5 secondary school qualification can be eligible to enroll in the Health Worker Training Courses after obtaining the Certificate in Advanced Training for Care Workers. Upon completion of the Health Worker Training Courses, they can apply to become registered health workers, allowing practitioners to enhance their vocational qualifications and professional skills, and therefore helps to attract more talents to join the industry.

Enterprises and training institutions shared their experiences in programme development

Mr. Timothy LEUNG of AAT shared his perspective from the angle of an enterprise, highlighting the benefits of applying the VQP in talent development within the logistics industry. Mr. Leung stated, "The VQP is an excellent toolkit to enhance employees' competitiveness. After completing the VQP courses, employees can acquire qualifications relevant to their job positions, helping them to progress to higher-level qualifications." AAT applies the VQP in

human resource management and training, and actively develops internal training programmes based on the VQP. This serves as an excellent example for other industries that currently do not have licensing requirements.

Furthermore, Mr. Patrick PANG of ERB and Ms. Elite NG of HKUSPACE also shared their experiences in developing the VQP courses and their future directions. Mr. Pang shared, "Since the launch of the VQP courses, they have been beneficial to a wide range of individuals. The courses adopt Units of Competency (UoCs) from the Specification of Competency Standards and are in line with market needs. They enable practitioners to acquire the necessary job skills in their respective industries and pave ways for their career advancement. It is encouraging to witness the increasing participation of various industries in the development of the VQP."

Ms. Ng shared that HKUSPACE has launched the "Certificate for Module (Train-the-trainer for Security Services" programme to meet industry needs. "When designing the course, we referred to the curriculum requirements of the VQP. The UoCs and assessment guidelines in the VQP are clear and detailed, which facilitated the development of course content by training providers."

The inauguration ceremony for the application of Recognition of Prior Learning (RPL) for Voluntary Registration Scheme for Vehicle Mechanics (VRSVM) was held on 17 November, 2023. The Government launched the VRSVM In 2007 to enable experienced vehicle mechanics to obtain registration through the scheme, thereby recognising their qualifications and professional skills.

This year, in order to further enhance the professional level of licensed vehicle mechanics and meet the industry's development needs, the Electrical & Mechanical Services Department (EMSD), Qualifications Framework Secretariat (QFS), Vehicle Maintenance Technical Advisory Committee, and Vocational Training Council (VTC) have collaborated to apply the RPL mechanism within the VRSVM. This not only allows licensed mechanics to obtain the QF Level 3

qualification, but also enables experienced vehicle mechanics to participate in the VRSVM through the RPL mechanism, thereby raising the overall professional level of the industry and encouraging continuous professional development within the sector.

During his speech at the inauguration ceremony, Mr. Edward MAK, Deputy Secretary of Transport and Logistics Bureau, expressed, "I am delighted to witness the collaboration between the VRSVM and the RPL mechanism. I believe that this partnership can propel the industry's training to a new stage. It is hoped that this can enhance the professional level of the vehicle maintenance industry and achieve sustainable professional development within the framework of the vocational pathway."

Starting from 1 September, 2023, the scope of application for Recognition of Prior Learning (RPL) in the elderly care service industry has been expanded from "Residential Care" to include "Community Care and Support". This enables practitioners who have been working in both "residential care" and "community care and support" services to apply for recognition. Certain RPL qualifications are also available to carers who may not have formal work experience in elderly care services.

To celebrate this new chapter of implementing the RPL in the elderly care service industry, the Elderly Care Service Industry Training Advisory Committee (ITAC), in collaboration with the Qualifications Framework Secretariat (QFS) and Hong Kong Association of Gerontology (HKAG), which serves as the Assessment Agency of RPL for the elderly care service industry, coorganised an inauguration ceremony on 18 October, 2023. During the ceremony, representatives from QFS and HKAG introduced the

latest developments and application details of RPL in the elderly care service industry. Furthermore, 20 organisations became partnering institutions, pledging their support for RPL and receiving cooperation certificates from HKAG. The event attracted nearly 100 attendees from the industry, professional bodies, training institutions, and relevant government departments.

There are currently 45 qualifications available for application under RPL. Some of these qualifications have a five-year transitional period (from 1 September, 2023 to 31 August, 2028), during which practitioners can submit their applications by providing documentary proof of their work experience.

In addition, individuals who do not have formal work experience in elderly care (such as those who have cared for elderly family members or volunteered) can also contact the assessment agency, HKAG, to apply for the following eight qualifications.




Award Scheme for Learning Experiences

The application period for this year's Award Scheme will begin in March. Detailed information will be announced on the QF website.


